

**Waiver of Liability Form Assumption of the Risk and Waiver
of Liability Relating to Corona virus/COVID-19**

The novel corona virus ("COVID-19") has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. The EDA Flyers Youth Track Club has put in place preventative measures to reduce the spread of COVID-19; however, cannot guarantee that you will not become infected with COVID-19. Further, attending any program or activity with EDA Flyers Youth Track Club (including but not limited to track meets, practices or other outings) could increase your risk of contracting COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance with EDA Flyers Youth Track Club or ("Claims"). I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the EDA Flyers Youth Track Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after attending any EDA Flyers Youth Track Club program or activity.
